## CALL OF SELECTION FOR AWARDING 5 FINDOMESTIC "PAOLO VALENTI " SCHOLARSHIPS FOR STUDENTS FROM DISADVANTAGED COUNTRIES ENROLLED IN A. A. 2024/25 AT THE FIRST YEAR OF THE MASTER'S DEGREE COURSES OF THE SCHOOL OF ECONOMICS AND MANAGEMENT

### Article 1- Announcement of the call

A Call for applications is announced to award 5 Findomestic "Paolo Valenti " scholarships for students from disadvantaged countries, enrolled in a.y. 2024/2025 for the first time at the first year of one of the Master's Degree Courses of the School of Economics and Management of the University of Florence:

LM 77 Accounting, Auditing and Control;

LM 49 Design of Sustainable Tourism; LM

56 Economics and Development;

LM 16 Finance and Risk Management;

LM 77 Government and Business Management;

LM 56 Sciences of Economics;

LM 82 Statistics and Data Sciences.

The amount of every scholarship is 4,000 euro, gross of the duties of the receiver, and will be paid in 2 installments (see article 4).

### Article 2-Admission Requirements

Students who satisfy the following requirements can apply for the present call

1. Citizenship of a disadvantaged country. For the purposes of this call, disadvantaged countries are those with Human Development Index less than **0.800** (reference <https://hdr.undp.org/data-center/country-insights#/rank> );
2. To have obtained the BA degree not before April 30th, 2020;
3. To be regularly enrolled for the first time at the first year of one of the Master's Degree courses listed in art.1 for the academic year 2024/2025, enrollment **within November 8th, 2024**;
4. ISEE income acquired by the University not exceeding 30,000 euros;
5. Don't be subject to penal sentences or penal procedures.

### Art. 3- Amount of the scholarship and payment method

The amount of each scholarship is 4,000 euro, gross of the duties of the receiver, and will be paid in 2 installments:

The first installment, in the amount of 2,000 euro, will be paid when the selection is concluded;

The second installment, in the amount of 2,000 euro, will be paid when the student will enroll to the second year of the course;

The payment of the second installment is subject to the successful outcome of the verification of the income and merit requirements indicated in Article 4, the ISEE value valid for the right to university study acquired by the University will be considered.

### Article 4 - Requirements for the payment of the second installment

The second installment of the scholarship will be paid to the winners of the selection when they will enroll in the second year of the course, subject to verification of the possession of the following income and merit requirements:

Acquisition of at least 20 CFU, at the time of renewal of enrollment in the second year of the course;

ISEE income acquired by the University not exceeding 30,000 euro.

In the event of a negative outcome of the verification of the requirements described above, the second installment will not be paid. The not paid amounts will be used for the allocation of the scholarship for the following years.

#### **Article 5-Application**

Please write in the subject of the email "Application for Scholarship Call Findomestic Paolo Valenti".

The date of the terminal of this university receiving the applications is authentic. The Administration declines all responsibilities for the non-receipt of applications resulting from third party liability.

Applications must be completed according to the included facsimile (annex A) and signed in the original with a handwritten signature.

Please include a copy of a valid identity document.

Applications received in ways other than those indicated and/or received after the deadline will not be considered valid and candidates will not be admitted to the selection.

#### **Article 6-Evaluation Committee**

The Evaluation Committee will be composed by the Dean of the School, or his delegate, and the Presidents of the Study Courses referred to in Article 1, or their delegates.

#### **Article 7-Evaluation procedure**

The scholarships will be assigned by the Evaluation Committee described in art 5 whose judgement is unquestionable. The ranking will be drawn up by assigning a higher score to candidates with citizenship of countries with a lower Human development Index;

If applicants are ranked equally, the scholarship will be assigned to the younger applicant.

If the Evaluation Committee decides the grant cannot be assigned, the amount will not be assigned.

#### **Art. 8-Incompatibilities**

The Paolo Valenti Scholarship is incompatible with the DSU's scholarship.

If the top-ranked applicant is the winner of the DSU scholarship, he will be excluded from the ranking of Paolo Valenti scholarship.

The applicant in the immediately following position will be named as the winner.

#### **Art. 9- Ranking publishing and acceptance of scholarship**

The rankings will be issued through a decree of the President of the School and published in the Albo Ufficiale dell'Università degli Studi di Firenze (the official gazette of the Università degli Studi di Firenze) <https://www.unifi.it/albo-ufficiale.html> and in the website <https://www.economia.unifi.it/>.

The publication of rankings on these websites will be the only legal notice.

After the rankings' publication, winners will be contacted at the email addresses indicated in the applications, and invited to accept the scholarship by filling a form which will be sent them and which is available at <https://www.economia.unifi.it/>

If a winner does not fill and send the form within five days after reception of the email, then he will be considered as willing to decline the scholarship.

In the event of a waiver, the winner will be the participant ranked in the following position.

#### **Art. 10- Administrative Unit in charge of the procedure**

According to the law n. 241/1990 and following amendments, and the "Regolamento sui procedimenti amministrativi dell'Università degli Studi di Firenze", the administrative unit in charge of the procedure is the School of Economics and Management, Scuola di Economia e Management.
